OFFICIAL CHILD PROTECTION CODE OF CONDUCT

ESNNA PREVENTION NOTICE & COMPLIANCE

"In Peru, the Commercial Sexual Exploitation of Children and Adolescents (ESNNA) is a severe criminal offense punished by law with prison sentences up to life imprisonment."

In strict compliance with **Peruvian National Law N° 30802**, its regulatory frameworks, and mandatory guidelines issued by the **Ministry of Foreign Trade and Tourism (MINCETUR)**, the travel agency **365 Deluxe SAC** (operating under the commercial brand **365deluxe** via www.365deluxe.net) establishes this binding official protection notice.

1. OUR ABSOLUTE CORPORATE POSITION

365deluxe maintains a strict, zero-tolerance policy against any practice, behavior, or operational activity linked directly or indirectly to the Commercial Sexual Exploitation of Children and Adolescents (ESNNA) within the entire tourism sector. We reject, condemn, and actively prevent any exploitative conduct inside hospitality services, private transportation transfers, or tourist excursion spaces.

2. MANDATORY STAFF AND SUPPLIER REGULATIONS

All administrative employees, operations managers, private drivers, local professional tour guides, and boutique lodging providers affiliated with 365deluxe are contractually required to:

- Strictly refuse and block any access or behavior that threatens the moral, psychological, or physical integrity of minors.
- Immediately verify the legal identity of all traveling minors, checking current passports, DNI records, and parental authorization documents before executing transportation or hotel check-ins.
- Report any suspicious individual, customer request, or operational anomaly that puts a minor at risk to judicial and police departments.

PERUVIAN PENAL CODE FRAMEWORK (LAW N° 30802 MANDATE)

According to the national criminal legal structure of Peru, anyone who promotes, facilitates, finances, or participates in the commercial sexual exploitation of a minor will face immediate incarceration. Tourism operators who fail to report these severe crimes within their designated service spaces are legally prosecuted as accomplices under criminal omission codes.

3. DIRECT REPORTING PROTOCOL

If you witness or suspect an ESNNA violation during your journey in Peru, report it instantly:
